1. WHAT ARE COOKIES AND WHAT ARE THEY USED FOR?

A cookie is a small text file that is placed on your computer by the server of this website, the server of the web applications that you visit or by third-party servers that may or may not cooperate with this website. The cookie file contains a unique code that allows your browser to be recognised. They generally make the interaction between the website user and the website easier and faster. They help - on an IT technical level - in navigating between the different parts of a website for the user and are responsible for collecting different categories of data.

2. WHAT COOKIES ARE USED ON THIS WEBSITE?

- **Necessary cookies**, which are necessary for the website to function. Without these cookies, the website simply (or by law required features, such as cookiebanner) does not work. Consequently, these cookies are set automatically from the moment you visit the website.
- **Other (non-necessary) cookies**, which will only be placed after you have given your express consent during your first visit to the website. You may not be able to use all of the features of this website if you reject certain categories of non-essential cookies.
 - **Functional cookies**, which track information about your choices and preferences on the website.
 - **Analytical cookies**, which collect information about the surfing behaviour of website users and the performance of the website. This allows the website (and its use) to be improved.
 - **Marketing cookies**, which also collect information about the surfing behaviour of website users. This is used to compile a user profile with a view to providing a more personalised service and/or advertising relevant to you.
